The co-decision procedure is a legislative process introduced by the Treaty of Maastricht (Treaty on European Union) 1991 and now enshrined in Article 294 TFEU. In the co-decision procedure, the European Parliament and the Council jointly adopt (i.e. co-decide) legislation. The Parliament now shares legislative authority with the Council.

A quorum of two thirds of members with voting rights is necessary for a vote to take place. The president may initiate a secret ballot in the Governing Council at the request of at least 3 of its members. Decisions may be taken by written procedure, unless at least 3 members object.
