When discussing social inclusion, its twin- social exclusion –necessarily arises. Social exclusion is the "restriction of access to opportunities and [a] limitation of the capabilities required to capitalise on these [opportunities]." We also know that there is a correlation between discrimination and social exclusion. Many exclusions stem from discrimination of individuals or groups on the grounds of their attributes, or social, economic or physical disadvantages.
