'Private provision' is taken to mean the production, provision, or delivery of public services by the private sector in one or more ways. The author's starting point is that private providers are generally more likely than governments to meet public needs, but he discusses five situations described in the economic literature in which market failure is said to justify government intervention:

As long as a service remains in the public sector it retains at least the potential to be directed by meeting the needs of the consumer - the public. Whether it does so depends on the quality of management and the degree of pressure on the relevant public authority to deliver a service.

Public service markets usually involve a contract between a service provider and a public sector body such as a central government department, a local authority, or a clinical commissioning group. This body purchases services on behalf of its citizens, who may then be able to exercise choice about exactly which service or provider they use.
